2B. Project Description

1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with 24 CFR 578.7:

Central MN CoC (CNC) will use planning funds and in-kind matching funds to continue coordination with a full range of agencies and programs to develop, evaluate, and implement system and process improvements. Ongoing review and updates to Policies and Procedures will ensure a more efficient and effective system to reduce the length of time homeless and to set CoC funding priorities while ensuring fair, consistent, and equitable outcomes for all subpopulations. Input and collaboration will come from state and federal agencies, CoCs, health agencies, community agencies, housing providers and those who have been or are currently homeless. Areas of specific focus will continue to address the increasing needs of youth, singles, families, veterans, seniors, and those experiencing or fleeing from domestic violence and human trafficking. Policies and procedures as well as programmatic outcomes will be regularly monitored, reviewed, and modified as needed to ensure equity for BIPOC individuals as well as those in the LGBTQ+ community. Priorities will be adjusted to meet the identified needs of specific populations. Additional focus will be placed on rural areas which will include finding and involving programs in areas currently underrepresented. Planning, evaluation, and training around assessments, certifications, and data entry to ensure all clients are correctly identified, assessed, and ultimately diverted, given appropriate referrals or correct placement into the Coordinated Entry System. Education and Training on the Chronic Homeless definition will continue throughout the CNC. These efforts will focus on certification of clients in a more efficient manner so that information on the Priority List is accurate, current, and complete. This will improve the accuracy of referrals for housing with the goal of decreasing the length of time homeless and equity across the referral process. CNC will continue to work with agencies to increase housing stability, reduce returns to homelessness and increase household income. There will be continued focus on eliminating disparities for BIPOC and LGBTQ+ people identified in these data categories. Increase formalized partnerships with health care agencies, mental health agencies, and law enforcement to create holistic systems that can identify individuals who will benefit from focused case management, interventions, and programmatic support to decrease use of emergency rooms and create greater stability in their housing and life outcomes. Agencies will be monitored on a quarterly basis. System Performance Measures will be reviewed, and areas of improvement identified. Quarterly Data Quality reports will be analyzed and utilized in identifying specific programs that may require focused training or technical assistance in order to improve programmatic results, data integrity, and client outcomes.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

The planning project funds will begin July 2022. CNC has already started a comprehensive review of the CE system policy and procedures and participated in technical assistance to continue improvement of policies, procedures, and accuracy of the Coordinated Entry System. CNC will implement the improvements we discover throughout this process on an ongoing basis before, during, and continuing after this grant period. Input and collaboration around our priority populations and best practices will happen monthly at the Coordinated Entry Advisory and CoC Full Membership meetings as well as other state and local community meetings. Additionally, a robust training program will be developed that will offer access to trainings around best practices, understanding policies and procedures, and successful implementation of changes and updates received throughout the grant period. Deadlines will be set to ensure completion of trainings and progress will be tracked using date and time stamps on emails. CNC will continue to monitor all agencies on an ongoing basis and receive System Performance Measurement and Data Quality reports on a quarterly basis with the goal of improving system performance measures. An HMIS/Data Committee has been developed through the CNC Governing Board which will be meeting at least quarterly to analyze data and recommend training or intervention as needed throughout the CoC.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

This funding will improve the CNC system by supporting us in our efforts to analyze and evaluate System Performance and Data Quality reports and ensure we are using best practices throughout our Coordinated Entry System. All CoC Policies and Procedures are undergoing a thorough review which will now include specific input from people with lived experience. Using effective and consistent policies should increase CoC-wide outcomes. This funding will allow continuous use of focused data to identify any needs or gaps so they can be quickly addressed. This will also allow the CoC to monitor programmatic spending to ensure that all grant funds are used and expected outcomes on data points such as maintaining/increasing income, returns to homelessness, and housing stability are achieved by all funded organizations across all populations.
