1. Catholic Charities Program Updates

Stacy Pederson

Closed Homeward Program which serves women and children ages 18-25. Emily's Place single women in transition. In process of closing Youth House 18-25. Board did not approve budget and decisions were made where cuts needed to be made. Lack of funding and programs operating in a deficit for a long time. Issues with residents and being able to serve them the right way. Youth house closed due to funding and operating in a deficit. Continue to serve youth in scattered site (SHY Program). Will continue with homeless outreach. CAMHI and Bridges Voucher programs will continue. HOPE program is discontinued which is ARMHS Services. Will continue mental health clinic. Domus will continue women and children 18 and up. Affordable housing will continue. CSP is closing (Under Hope). Referring households to other community providers. Youth Housing closing April 17th. Homeward and Emily's Place already closed.

2. ICA Updates TJ Yocum

Transition from HMIS Community Services to ClientTrack. Administrator will stay the same. Tentative launch date is July 1st but could be moved due to changes. QDQ is on hold right now and will come back in 2025 for users to get used to new system. New agency set-ups and new user training on hold. Help Desk hours reduced during transition period. Training date has not been set for ClientTrack.

3. MICH Rep Updates

Dani Linder is the new CoC MICH representative. Office of Justice Programs (Housing Specialist), support community and victim service providers with homeless programs. Be a liaison between MICH, CoC, and community providers.

4. Coordinated Entry Discussion

Households down from 300 to 180 on Priority List. January 2024: 41 total referrals, 4 accepted, 10 client rejections, 12 provider rejections, 14 open referrals, 1 HH not visible. Referrals sent out within 3 days of receiving request. February 2024: 74 total referrals, 3 accepted, 22 client rejections, 17 provider rejections, 30 open referrals, 1 HH not visible, 1 other.

5. Review HUD FY 2023 NOFO Scores

Length of Time Homeless and Exits to Permanent Housing Destinations and Retention of Permanent Housing CoC Strategy scored lower. Increasing Employment Cash Income 143.5 out of 200. 3rd lowest scoring CoC in MN.
