1. Odam Mobile Clinics

Josh Leopold/Dr. Odam

Set up a practice that has easy access for patients who experience with access. Clinics are in designated underserved medical areas. Housing education issues, low vaccination rate. First practice in South Minneapolis. Then St. Cloud and have been here for 5 years. Most of the practices in the area did not have technical support to support the need. Partnered with Blue Cross/Blue Shield to help create a mobile clinic. Focus is going to where the people are and can deliver primary services at their residences. Mobile clinic covers 16 counties (Clay, Becker, Otter Tail, Wadena, Cass Crow Wing, Todd, Morrison, Mille Lacs, Kanabec, Benton, Stearns, Sherburne, Kandiyohi, Meeker, and Wright) and will soon add Rice and Polk counties. Under contract with DHS to provide the mobile clinics in the 16 counties and UCare to their members. Also assist patients in transition with no insurance, and assist with completing professional Statements of Needs. Hoping to expand to Substance Abuse Assistance. There has been a reduction in the use of Emergency Room (Blue Cross). Will be adding mobile mammograms later this fall for woman underinsured and no insurance. Call to schedule an appointment. NOFO process potentially going to every 2 years. 43 HUD Field offices. Formula programs (19 grantees over \$80 million). Competitive Program (102 CoC grantees) Congress appropriates funds annually through the NOFO. 2023 over 200 grants over \$38 million.
