Single moms, single dads, largest family of 12, multigenerational families. Provide intense wraparound services. Path to Home Shelter program serves 5 families at a time. Supportive Housing Program includes 24 apartments or townhomes, 8 LTH, 6PWD, and 10 HPH.
