## Action Items

## Information & Discussion

- 1. MDVA Stable Housing Initiatives
  - Homeless Veterans Registry (HVR) does not have an income maximum.
  - Minnesota Department of Veteran's Affairs
    - i. Resources available for support for veterans and <u>former service members</u> (regardless of discharge or length of time served; *ex*.: Youth who didn't make it through basic training)
    - ii. Works within the CoCs with partners to assist in advocating and seeking services for veterans and former service members who are experiencing homelessness
  - Veteran Temporary Emergency Housing Program
    - i. Working with any veteran and their family experiencing homelessness when there's lack of access to shelter. Reimbursement to community service providers to place them in the hotel for 14 days (if chose not to engage in case management) can request 30-day extension with max of 3 extensions (90 days). A request variance can happen if the move-in date is verified after the 90 days.
    - ii. Meant to be ease of access to be able to shelter people
    - iii. Agree that they will be on the Veteran registry
    - iv. If not registered as provider- you will be requested to complete a W-9 before reimbursement
  - Various incentive programs and funds available to assist with overcoming barriers with landlords (only a one-page application for landlords and property managers)
  - Short-term subsidies available
  - Be sure to ask, as providers, if someone has a history of service.

# For Veterans Temporary Emergency Housing Program:

Question: Is this for service providers only focusing on serving the veteran population, or is it any housing program?

If anyone reports any form of service, make sure they fill out the HVR application referral (if they are willing) to get on the list and receive extra support specific to them. Any service provider can utilize these programs, not just those only serving veterans and former service members.

Question: How does this work for individuals fleeing interpersonal violence?

<u>For individuals experiencing/fleeing interpersonal violence</u> (ex. Domestic violence, sex trafficking, human trafficking): Non-public facing HVR application for those facing interpersonal violence of any kind, so that their privacy and safety is protected and mindful of how we ask questions- will have a direct call with a coordinator.

Question: Do we need to get verification of their service history/status? Only need to submit the application, and then they check for verification on their end with that ROI that is included.

Question: How do you verify that shelter access is unavailable? You are trusted as a community service provider that you have done your due diligence and confirmed this.

Question: Does this cover damage costs that may occur? Allows up to \$2000 reimbursement for damages that may occur.
